By dissecting real-world infrastructure case studies, the course provides tangible insights into how to navigate complex stakeholder environments, manage extensive supply chains, and leverage digital transformation. The focus is less on software tools and more on the strategic thinking, leadership, and organizational alignment required to build a resilient and value-driven asset management capability.
